1. Roll Call

The meeting was called to order by the Chair, Charles Walsey, at 8:00 A.M.

The Chair then called the roll, and noted that all Supervisors, except Supervisor Portnoy, who had a conflicting meeting, were present.

2. Approval of Agenda

After a motion by Supervisor Elsner and second by Supervisor Johnson, the Board unanimously approved the Agenda.

3. <u>Approval of Minutes</u>

By motion by Supervisor Elsner and second by Supervisor Johnson, the Board unanimously approved the minutes of the Board of Supervisors' Meeting of December 16, 2019.

4. Engineer's Report

The District Engineer distributed some handouts (copies attached) and gave his report. He said that the Army Corps does not intend to lower the lake elevation in the immediate future. There has been no action on State Road 7. There was an update on the County's Five-Year Road Plan. There has been no construction activity on five road segments near the District. He has submitted the quarterly water use report to SFWMD. He went over a table of the District's historic water use. He said our water use permit expires in 2029. He discussed the process for changing the permit for FPL's energy center. This will affect both drainage and water use. SFWMD will need to approve the stormwater permit and any changes to the water use allocation for FPL. Mr. Poyner will coordinate with FPL, with the District Engineer's assistance. The District Engineer described the request from Yee Investments for an increased water allocation. The request is for several times more than the amount of the current allocation. Yee will have to negotiate an increase with SFWMD. If Yee is successful, then the Districts master water use permit as well as Yee's secondary user agreement will need to be amended.

5. Operations Manager's Report

The Operations Manager discussed his written report, a copy of which is attached. Mr. Poyner described some canal work that he is putting together an estimate on, which he will present at the next meeting.

6. Treasurer's Report

The Treasurer was unable to attend due to a conflict.

7. Attorney's Report

The District Attorney reported that he received updates on the supervisors' addresses and contact information and will be submitting them to the Commission on Ethics for the annual financial disclosures.

8. <u>Comments by Supervisors</u>

There were no additional comments by Supervisors.

9. <u>Comments by Public</u>

There were no members of the public present.

10. Announcement of Next Meeting Date

Lake Okeechobee Regulation Schedule (LORS) -

Re-evaluation of LORS 2008 (No changes from November 18, 2019)


The U.S. Army Corps of Engineers (USACE or Corps) is re-evaluating the LORS 2008 to assess opportunities to balance project purposes for flood control, water supply, navigation, recreation, and preservation of fish and wildlife resources. The end result of the LORS 2022 Study will be a new Lake Okeechobee System Operating Manual (LOSOM). The LOSOM project began in February 2019 with National Environmental Policy Act (NEPA) scoping meetings and is expected to be completed by October 2022 with the Record of Decision. As of October 2019, the project is in the Plan Formulation phase.

Recent Revisions- Planned Deviation

At the end of July 2019, the USACE sent out notice of a proposed deviation from the LORS 2008 (and has, in fact, already implemented a deviation). The stated goal of the deviation is the reduction of risk to public health and safety associated with harmful algae blooms (HABs). The notice also states that "The planned deviation will allow the Corps to alter the timing and volume of Lake Okeechobee releases to the WCAs, east, and/or west to allow for greater flexibility with water management decisions when HABs are present or forecasted in Lake Okeechobee, the St. Lucie or Caloosahatchee estuaries or the system of canals that connect them ."

The USACE's intent is to make slightly larger releases to the east and west than is called for by the LORS 2008 Part D (which establishes releases to estuaries) and make releases south when LORS 2008 Part C (which establishes allowable releases to the Water Catchment Areas (WCAs)) does not allow them. The total annual volume of releases from Lake Okeechobee will remain consistent with what is allowed under LORS 2008.

At the December 3, 2019 Palm Beach County Board of Commissioners meeting, Colonel Andrew Kelly (USACE) reported on the Army Corps operational changes for Lake O during the past year. The USACE set out to lower Lake O stages and now are accessing how well it worked. USACE reported that the submerged aquatic vegetation in the lake increased about 5 times (5,000 acres-feet to 20,000 acres-feet), that there were no significant impacts on agricultural issues and that the lake stages never got into the water conversation zone requiring water storage constraints. USACE considered it a success. The Colonel provided an update on addressing other Lake O related issues such as the 8,000 +/- comments on the Lake O proposed deviation schedule (USACE responses are 1 to 2 months out), Lake O Re-evaluation of LORS 2008 schedule – the USACE is engaging public comments and evaluating alternatives with a completion date in 2022, status of Herbert Hoover Dike improvements (completion by 2022) and identification of ongoing restoration projects (Loxahatchee River, Lake Okeechobee, storage improvements north of the lake, Everglades (EAA Reservoirs).



The one year graph of the Lake Okeechobee water level and management zones is shown below.

<u>State Road 7 Extension</u> – <u>(No changes from August 19, 2019)</u> On July 17, 2019 Florida Department of Transportation and Palm Beach County submitted letters to South Florida Water Management District requesting to withdraw the Environmental Resource Permit (Acreage Reliever Road Application No. 150410-S). The request was granted.

County Five Year Road Program Fiscal Year 2020 - FY 2024

On December 17, 2019, the Palm Beach County Commissioners adopted an ordinance to amend the 5-year roadway plan. Construction cost estimates for projects beginning in FY 2019 were increased.

Seminole Pratt Whitney Rd. widening from 4 to 6 lanes from Orange to Northlake Blvd (1.8 miles) at a construction cost of \$11.5 million being in FY 2019 and \$600,000 in FY 2020.

Seminole Pratt Whitney Road and Northlake Boulevard intersection improvements at a construction cost of \$6.8 million being in FY 2019 and \$600,000 in FY 2020.

Northlake Blvd East of Seminole Pratt Whitney Road east to Hall Blvd widening from 2 to 4 lanes (1 mile) at a construction cost of \$6.2 million and \$800,000 for construction in FY 2020.

Northlake Blvd east of Hall Blvd. to Coconut widening from 2 to 4 lanes (2.4 miles) at a cost of \$1.1 million in FY 2019 and \$2.6 million in FY 2020 and \$5.6 million in FY 2021.

60th Street North West of 140th Avenue to Avocado Blvd. Study, **cost of \$1.6 million**, design and right-of-way acquisition for a 3-lane road in FY 2020 and \$100,000 for study, right-of-way acquisition and mitigation in FY 2022.

60th Street North Avocado Blvd. to East of 120th Avenue North. Construction of 1.6 miles of three land road at a cost of \$200.000 for right-of-way and mitigation in FY 2020 and construction cost of \$7 million in FY 2022.

SFWMD Water Use Permit (No changes from November 18, 2019)

Fourth Quarter usage reports for October through December are being processed for submittal to SFWMD. A copy of the historical monthly and yearly amounts is attached.

Herbert Hoover Dike (No changes from September 17, 2018)

The construction contractor, Harry Pepper and Associates, continues to make progress on construction of replacement culvert structure while temporary culvert provides service. Current construction activities include: (1) installation of rebar, formwork and concrete placement for the Lake side head walls for the new culvert structure and (2) concrete pours on monoliths that will encase the newly installed culvert structures. Scheduled completion of the C-10A culvert construction contract is June 2020.

Loxahatchee River Restoration Local Initiative (No changes from December 17, 2019)

On December 3, 2019 the Board of County Commissioners (BCC) was provided a brief from County staff on the Loxahatchee River Restoration efforts. This included the County activities to evaluate alternative storage options for the proposed Mecca Reservoir. Preliminary results of County's evaluation of three alternative local initiatives for the Mecca Reservoir indicate that all three can meet the Loxahatchee River target wet season flows, are within 10% of the USACE Plan dry season flow, and are within a +/- 5% range in estimated costs of the USACE Plan. The BCC approved staff's letter to South Florida Water Management District (SFWMD) supporting SFWMD efforts and the U.S. Army Corps of Engineers to restore the Loxahatchee River watershed. The County also recommended that the SFWMD Governing Board communicate their support of the Loxahatchee River Watershed Restoration Project to USACE to enable authorization by Congress in 2020. Additionally the County requested that SFWMD letter of support to USACE recognize the County's concern for the Mecca Reservoir and allow for some flexibility to evaluate alternative replacement water storage options for the Mecca Reservoir.

Yee Family Farms Irrigation Connection Permit

Yee Farms submitted an application of irrigation withdrawals and a connect permit. The unresolved issue consists of the higher monthly water use allocation and annual allocation requested by Yee Family Farms as compared to the amount authorized by CGCDD SFWMD Water Use Permit.
