5. Operations Manager's Report

The Operations Manager reported on the onsite and offsite water levels. He said he is mowing the canal banks. He said that ITID has taken over the maintenance in Santa Rosa Groves. He discussed the timing of the replacement of pipes at Carrol Street and 59th since ITID will be putting down millings in about 6 months. He said the two existing pipes are old and should be replaced. He has one pipe and would need to purchase one pipe. He will get a quote. The issue is that the replacement must be done when the L-8 water level is low so that he wouldn't need to dewater. In June, he should be able to get SFWMD to lower the water level. He also said that he needs to clear about a mile of brush along Marie Court. He can't burn it since the power lines are there. He thinks that he has a contractor who can grind the brush for a reasonable cost, estimated at \$15-17 thousand. He will then need to reshape the canal bank for about the same cost. He said he needs to complete the rest of Louise Street. He said he has about a year before ITID does the roads on the exterior of Santa Rosa Groves. He needs to do the work before the roads are improved.

The Treasurer was not present so there was no Treasurer's report this month.
